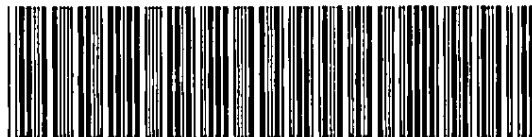

Article I

The name of the corporation shall be: Y.V.S. Foundation of Hope, Inc.

Article II

The principal office of the corporation is 7705 CR 136 Live Oak, Florida 32060, mailing address the same.

Article II Purpose

Empowering all people to make positive choices in their life related to events and circumstances in one's life or the world at large. Having workshops, forums, education, about peer pressure, self esteem, purpose, acceptance, self discipline, honesty, kindness, goals, prison, drugs, HIV/AIDS, health fairs and scholarships.

Y.V.S. Foundation of Hope, Inc. will furnish services that will make a difference in the quality of life for affected and infected HIV/AIDS. Confidential, free HIV testing. Provide pretest counseling, learn the results and discuss the future. Many people with HIV/AIDS don't know they have the viruses. Learn how to prevent becoming infected with HIV/AIDS. Live with HIV/AIDS if you are infected. Don't spread HIV/AIDS if you are infested. Misconceptions about aids not just young people, it effects young adulthood, middle age, sex does not stop @ 50, it effects everybody. Article IV Directors

1. General Powers. Business and affairs of the corporation shall be managed by it's Board of Directors.

2. The election, term of office initial Board of Directors shall consist of Officers & Committee Chairpersons members of Y.V.S. Foundation of Hope, Inc., there is no limit of members, it needs to be odd amount to alleviate the possibility of a tie during voting process. Board of Directors shall hold office for a term until their death, removed or until successor are elected and qualified.
