Article 1.

The name of the corporation is Church at O.R.L.K. Inc.

Article 2.

Notwithstanding any other provision of these articles, the corporation shall not earry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
