to the Florida Department of State, Division of Corporations in which there were activities of fraudulent claims and
amendments made to the Articles of KANUNI SABA, INC. The entails of said activities included the removing of
all current Board Members (proceeding July 2, 2018) of KANUNI SABA, INC., and replaced with other names of
Shannon Dennis, Shaquanda Looper and Alonzo Lawrence, along with an attempt name change of the company
from KANUNI SABA, INC. to "Elder Youth Foundation, Inc." Aforementioned activities by Shaquanda Looper is
in violation of Florida Statute section 817.155 encompassing providing false information with the intention to
mislead and misinform the public. Furthermore, be it advised that having once served in a role of trust with
KANUNI SABA, INC., it was unanimously resolved by the acting Board Members to remove Shaquanda Looper
from her role with KANUNI SABA, INC., on the grounds of misusing an entrusted role where there was a
discovered theft of company funds- a Breach of Fiduciary Duties, credit card fraud and abuse of the 501 c 3 tax
exempt status of KANUNI SABA INC. for personal gain. Thus necessitating filing Articles of Amendment to the file
of KANUNI SABA, INC., this reflected July 2, 2018 with the Department of State, Division of Corporations.
