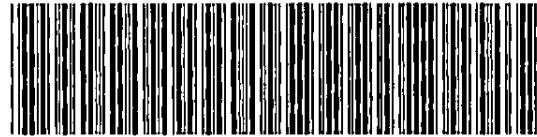

**ARTICLES OF INCORPORATION  
OF  
PRETTY GIRL WORLD FOUNDATION, INC.**

**ARTICLE I. NAME OF CORPORATION**

The name of the corporation is **Pretty Girl World Foundation, Inc.**

**ARTICLE II. PRINCIPAL OFFICE**

The principal office of the organization is located at **5360 NW 78th Ave  
Lauderhill, FL 33351.**

**ARTICLE III. PURPOSE**

The purpose for which the corporation is organized is: *To positively impact the lives of women through instructional materials, motivational speaking, literacy, workshops, and forum to increase self-esteem and mental competency and clarity for holistic living.* This corporation does contemplate pecuniary gain or profit to its members, and is organized exclusively for charitable and education purposes within the meaning of the Internal Revenue Code.

It shall have the power to do all lawful acts which are, in the opinion of the Board of Directors of the corporation, necessary or desirable to carry out the purposes and accomplish the objectives of the corporation, and which are consistent with Florida law. The corporation shall have all powers granted to the nonprofit corporations under Chapter 617 of the Florida Statutes, whether or not specifically enumerated in these Articles of Incorporation or the bylaws; provided, however that it shall not have any power that would disqualify it as a nonprofit corporation under state and federal law.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

The corporation shall exist perpetual, unless dissolving according to law.


## ARTICLES IX. POWERS


## ARTICLE X. DISSOLUTION




