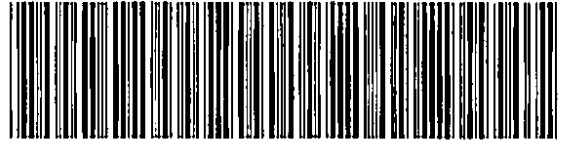

AMENDING- ARTICLE III- Angels' Path Foundation creates awareness regarding women, teens and children's rights victims of sexual assault and abuse. The foundation is organized and shall be operated exclusively for exempt purposes as provided by Section 501(c)(3) of the Internal Revenue Code as amended or corresponding future federal tax legislation.

ADDING- ARTICLE IX- Upon the dissolution or winding up of the Foundation, the remaining assets after payment (or provision for payment) of the foundation's debts and liabilities, shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or legislation, or shall be distributed to the federal, state or local government for a public purpose.
