



Amendments to Articles of Incorporation for

Bikers 4 Boobies - A Cancer Support and Fund Raising Organization, Corp.

Article III- to be added to Article III as follows:

Said corporation is organized exclusively for charitable, educational purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue code, or the corresponding section of any future federal tax code.

Following articles to be added:

Article IX - Activities of the corporation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable expenses for services and to make payments and distributions in furtherance of the purpose set forth in Article III. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

Article X - Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes, with the meaning of section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
