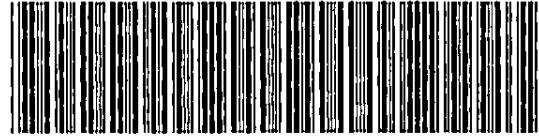

TWO: This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ.
