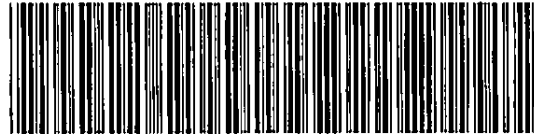

**Article I NAME**

The name of the corporation shall be **RA HOME LIFE SERVICES, INC.**

**Article II Principal Office**

The place of business and mailing address of the corporation shall be 2002 42nd place, Vero Beach, FL 32967

**Article III Purpose**

Section 1

The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501 C (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Review law.

Section 2

Notwithstanding any other provisions of these articles this organization shall not carry on any activities not permitted to be carried by an organization exempt from Federal income tax under section 501 C (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

**Article IV Manner of Election**

The business affairs of this Corporation shall be managed by a Board of Directors. The Board of Directors shall be members of the Corporation. Members of the board of directors shall be elected to hold office in accordance with the By-Laws. The Corporation shall have three(3) directors initially. The numbers of directors may be increased from time in accordance with the By-Laws, but shall never be less than three(3).

## Section 2


