The Options Network, Inc. Articles of Incorporation Attachment

ARTICLE III- PURPOSE

- 1) The Options Network, Inc. is a newly formed nonprofit organization dedicated to effectively connecting those in need to services in their community. We will accomplish this goal by developing a network that will provide free or low-cost transportation services to individuals in need. This service would be available to provide transportation to medical appointments, job interviews, or other charitable services in the community. In the future, as our organization grows, we would like to expand our program to serve the community in additional ways such as offering employment training and providing other charitable services. Through our organization's programs and services, we hope to make a positive impact in the lives of those we work with and the community as a whole.
- 2) No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- 3) The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX - DISSOLUTION

- 1) The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- 2) The manner of distribution of assets in this Corporation's winding up is as follows:

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government for public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
