ARTICLE I NAME

The name of the corporation shall be; THE CUBAN BAR ASSOCIATION, INC.

ARTICLE II OFFICE

The principal initial office of the Corporation in the State of Florida shall be located in Mami-Dade County at 9041 N. Kendall Drive, Miami, Fl 33176-2119

ARTICLE III PURPOSE

As a Corporation Not for Profit the purposes are as follows:

- 1. This Corporation is one which does not contemplate pecuniary gain or profit to the members thereof. It is organized for not for profit purposes.
- 2. To promote unity among all the Cuban attorneys and Cuban-American attorneys.
- 3. To establish contact and promote unity, for the formation of Project of Fundamental Law for the Reconstruction of a Cuban Republic (Proyecto De Ley Fundamental de Reconstruccion de la Republica de Cuba), based on the 1940 Cuban Constitution, among Cuban-Americans and Cubans in Exile and those in opposition to the Castros' communist regime residing in Cuban.
- 4. To promote the cooperation between the Havana Bar Association, Inc.; the Cuban-American Bar Association (CABA); Cuban attorneys in exile; Cuban attorneys residing in Cuba; attorneys In Madrid, Spain, Mexico, Canada, Puerto Rico, Central & South America as well as attorneys residing in the Caribbean area, in order to help the Cuban people obtain their freedom and establish a Country of Law in their land.
- 5. To promote among all the Cubans the knowledge of 1940 Cuban Constitution.
- 6. To cooperate with public and private agencies in the developing of armonius community Relations.
- 7. To encourage and assist efforts in behalf of Cuban attorneys who are or have suffered Political prison in Cuba.
- 8. To encourage and assist efforts on behalf of Cubans who are presently political prisoners In Cuba and/or any other country.
- 9. To do any lawful activity or business permitted under the Laws of the United States of America Or the State of Florida to a not for profit Florida corporation.
- 10. Not withstanding any other provision of these Articles this Corporation shall not carry any other Activity not permitted to be carried on by: (a) a Corporation exempt from Federal income tax Under Section 501(c)(3)of the IRS Code of 1954 or the corresponding provision of any future United States IRS Law or (b) or a corporation contribution to which are deductible under Section 170 (c) (2) of the IRS Code of 1954 or any other corresponding provision of any future United States IRS Law

ARTICLE IV MEMBERSHIP

- 1. All Cuban attorneys and Cuban-American attorneys that obtained their Law Degree in Havana University or any other university in Cuba established before January 1, 1959 or in any Foreign country.
- To be accepted as member of this Corporation the Cuban attorney and Cuban-American Attorneys need to be of good patriotic character, are interested in the purposes of this Corporation and are willing to cooperate actively with its purposes.
- 3. To be accepted as member it will be necessary to apply and swear that they are Cuban attorneys or Cuban-American attorneys and that they have not committed any Human Rights violations.

ARTICLE V BOARD OF DIRECTORS

 The affairs of this Corporation shall be manage by its initial Board of Directors consisting Initially by the Cuban attorneys and Cuban-American attorneys which name and address



appears in these Articles of Incorporation and who subscribe these Articles of Incorporation.

2. The number of Directors may be either increased or decreased from time to time by action In accordance with the provisions of its By-Laws.
