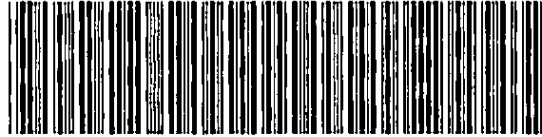

**ARTICLE III  
The Specific Purpose For Which This Corporation Is Organized**

The purpose of this organization, called Saint James Missionary Baptist Church of Sand Hill-Osteen, Inc. is organized exclusively for religious, charitable, literary and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Moreover, it is the intended purpose of this Church to ordain ministers through its licensing and ordination program and to oversee ministers of the gospel; to conduct the work of evangelism worldwide; to create departments necessary to support missionary activities; to engage in prison ministry; Bible studies; Nursing home visitations; and, to promote specials activities, such as Men and Women Day and Family

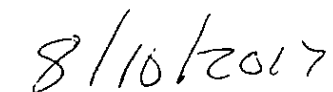

**Not-For-Profit**

This corporation is a not-for-profit corporation under Chapter 617.1006 Florida Statutes. No part of the net earnings of this corporation shall inure to the benefit of or be distributed to its members, trustees, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt for Federal Income Tax under section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law).

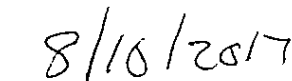

**ARTICLE IX**  
**Dissolution of Corporation**

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
