AMEND Article III

The specific purpose for which this corporation is organized is:

exclusively for educational and charitable purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including togething the Portuguese language and culture.

ADD Article VIII

The Corporation has all the powers granted corporations under the laws of Florida. However, notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal federal tax code.

ADD Article IX

No part of the net earnings of the Corporation shall interest to the benefit of, or be distributed to, its members of the Board of Directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the objects and purposes set forth herein. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or or intervene otherwise attempting to influence legislation, and the Corporation shall not participate in, (including the publishing or distribution of statements concerning) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt under Section 501(c)(3) of the Code, contributions to which are deductible under Section 170 of the Code. On the dissolution or winding up of this Corporation, its assets remaining after payment or provision for payment of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation, or corporation that is organized and operated exclusively for charitable, educational, and scientific purposes and that has established its tax exempt status under Section 501(c)(3) of the Code. In the event that this Corporation shall become a "private foundation" within the meaning of Section 509, then the Corporation's income for each taxable year shall be
