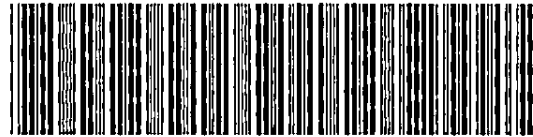

Add additional Article IX: Upon Dissolution of Corporation:

Any asset not so disposed of shall be disposed by the court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organization as said Court shall determine, which are organized and operated exclusively for such purposes.

No officer of Veterans Charitable Foundation, Inc. shall hold a position concurrently with a veteran's organization or related type of activity other than Veterans Charitable Foundation, Inc., unless disclosed to and approved by the Board of Directors. In no event shall a paid officer of Veterans Charitable Foundation, Inc. hold a position of responsibility with any other veteran's organization.
