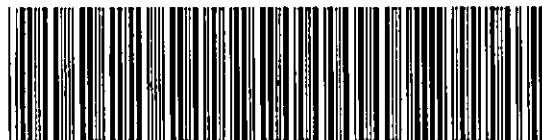

## ARTICLE ONE - NAME OF CORPORATION

## ARTICLE THREE – PURPOSE

Saint Teresa of Calcutta Catholic Community, Inc., is called to profess faith in Jesus Christ through the living Catholic Tradition, as handed to us from the Apostles through many generations. We are men and women, baptized in Christ. We are laity and ordained. We join together at the call of the Spirit to form a community of faith; to preach the Gospel of justice for the poor, the outcast, the sick, the disabled, the old, the young, and the imprisoned; to offer a refuge in Christ for those who suffer prejudice because of race, color, culture, philosophy, gender, marital status, sexual orientation or educational deprivation; and to conform our lives to the life and teachings of our Lord Jesus Christ through prayer, study, service, and the celebration of the Liturgy and Sacraments.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not consistent with the purposes of this corporation.

## ARTICLE FOUR – EXCLUSIVE ORGANIZATION

Said corporation is organized exclusively for religious worship and charitable endeavors, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE FIVE – DISSOLUTION OF THE CORPORATION**

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction within the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




