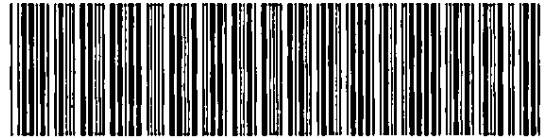



## ***Florida Nonprofit Filing***

### **Article I:**

### **Article IV:**

The specific purpose for which this corporation is organized:

Goebel Family Foundation Inc. is organized to provide scholarship awards to students of limited means who normally would not qualify for such awards. In addition our goal is to provide funds for biomedical research; programs to fight infectious disease outbreaks; health care for the poor, elderly and disabled. Notwithstanding in some cases to include such purposes as making distributions to organizations that qualify as exempt organizations under section 501 (c) 3 of the Internal Revenue Code or the corresponding section of any future federal tax codes.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, directors or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation, and no officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempt to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501 (c) 3 of the internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170 (c) 2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
