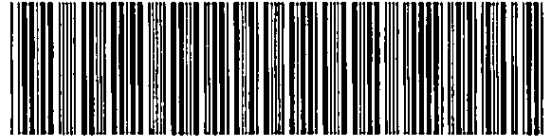

**ARTICLES OF INCORPORATION  
OF  
OSCEOLA COUNTY SHERIFF'S OFFICE COMMUNITY FOUNDATION, INC.**

\* A Florida Not For Profit Corporation \*

Pursuant to the provisions and requirements of Chapter 617, Florida Statutes, and for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, the following Articles of Incorporation are hereby adopted and set forth.

**ARTICLE I: NAME**

The name of the Corporation is the Osceola County Sheriff's Office Community Foundation, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office is physically located in Osceola County Florida at 2601 E Irlo Bronson Memorial Highway, Kissimmee, FL 34744.

**ARTICLE III: PURPOSE**

The purpose for which the Corporation is organized is to raise, receive, and hold funds, invest and administer property, and to make expenditures for the benefit of programs and activities that support crime prevention, law enforcement, correctional, and other areas of need in the community. Support shall be consistent with the furtherance of the goals and objectives of the Osceola County Sheriff's Office (OCSO). The Corporation is formed exclusively for the foregoing charitable purpose, all within meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as the same may be amended, modified, or replaced by any future United States internal revenue law. The Corporation shall have the power as needed, to effectuate the foregoing described purpose, to take, buy, manage, hold, sell, and dispose of the property, both real and personal, of this Corporation, subject to rules adopted by the Corporation.

#### **ARTICLE IV: BOARD OF DIRECTORS**

The Board of Directors shall be comprised of at least three (3) voting members. The election, composition and number of voting members of the board shall be stated in the Bylaws of the Corporation.


