ARTICLE 1 - Name

The name of the corporation is VETERANS-IN-ARMS VMC. INC. (hereinafter the "Corporation")

ARTICLE 2 - Principal Office and Mailing Address

The street address of the principal office of the Corporation is 106 Marshall Avenue, Lake Placid, Florida 33852. The mailing address of the principal office of the Corporation is P.O. Box 7091, Sebring, Florida 33872.

<u>ARTICLE 3 – Purpose</u>

The purpose of the Corporation is to support and defend the Constitution of the United States of America, preserve freedoms we have as American citizens and fellow Veterans, participate in local activities and charity events, teach protocol of the flag of the United States of America, to promote the interests and welfare of veterans, their families and local communities, and public charities that have tax-exempt status under Section 501(c)(19) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law, and without limitation as to other qualified and appropriate activities, to make charitable grants that comply with Internal Revenue Code Section 4945 and are not taxable expenditures as defined in Internal Revenue Code Section 4945.

Code of 1986, as amended, or any corresponding provision of any federal income tax law enacted in substitution of that Code, or by a corporation, contributions to which are deductible under Sections 170(a) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or any corresponding provision of any federal income tax law enacted in substitution of that Code.
