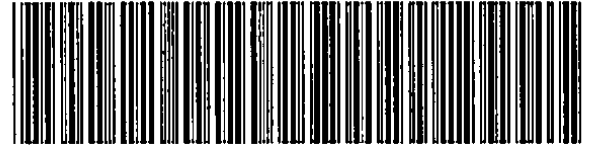

Amendment 8 to Article 1 Section 1.3 Number.

The number of board members shall include three (3) board members for each physical location in the Tampa Bay area.

Each location shall have three (3) representatives on the Board of Directors.

Amendment 9 to Article 1 Section 1.3 Number.

The number of board members shall include one (1) board member representing the virtual members. Today's Church will have one (1) Virtual Representative on the Board of Directors.

Amendment 10 to Article 4 Section 4.2 Term.

As representatives of the membership, the board members shall: (a) serve in a position on the Board of Directors; (b) that position is voted on bi-annually; (c) if a member does not serve in any position, they must step down from the Board of Directors, with the exception of the founding board members. (d) Any founding board member moving out of the State of Florida will no longer hold a seat on the Board of Directors.

Amendment 11 to Article 4 Section 4.7 Other Officers.

The Board of Directors shall consist of a Director of Membership. The Director of Membership shall: (a) create, update, and distribute information to current members as well as prospective members; (b) direct and oversee membership activities of the Church; (c) develop programs, initiatives and policies to increase membership while meeting the holistic needs of all people through fellowship, overflowing love and resources, outreach and teaching.

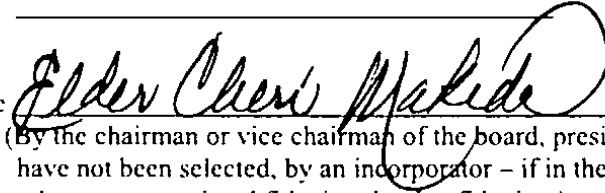
