ARTICLES OF INCORPORATION OF SCRIPTSHOT LEARNING CORPORATION (A FLORIDA NOT FOR PROFIT CORPORATION)

Effective upon September 6th, 2017, the undersigned, for the purpose of forming a Florida not for profit corporation under Florida Statute §617, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be SCRIPTSHOT LEARNING CORPORATION, a Florida not for profit corporation (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The principal office address of the Corporation is:



ARTICLE III - PURPOSES

The purposes for which this Corporation is organized shall be limited to those which are strictly charitable. The Corporation's purposes include but are not limited to:

- (a) Fundraising for and Providing children's services that are focused primarily in the areas of education and science (the "Purpose"):
- (b) to assist other not for profit companies in fulfilling the Purpose, and in the discretion of the Corporation's Board of Directors, to support other not-for-profit companies organized for charitable purposes; provided that each such corporation is an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, its regulations or the corresponding provision of any applicable future United States Internal Revenue law or regulation (hereinafter collectively referred to as the "Code") and in Section 509(a)(1) or (2) of the Code and further provided that the Corporation should be operated, supervised, or controlled in connection with cach supported organization within the meaning of Section 509 (a)(3) of the Code.
- (c) conduct any and all lawful affairs and business incident to the Purpose and to exercise any corporate powers enumerated in Chapters 607 or 617. Florida Statutes, as amended from time to time, but solely to benefit and further the interests and Purpose of the Corporation.



The purposes for which this Corporation is organized shall be limited to those which are strictly charitable. In no event shall this Corporation engage in any activity which would be contrary to the purposes and activities: (1) permitted to be engaged in by any organization the activities of which are exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986; or (2) of a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as hereafter amended, and the applicable rules and regulations thereunder.

The Corporation shall not engage, nor shall any of its funds, property, or income be used, in carrying on propaganda or otherwise attempting to influence legislation, nor shall the Corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office, nor shall the Corporation engage in subversive activities.

The Corporation shall not be operated for the primary purpose of carrying on an unrelated trade or business as defined in Section 513 of the Internal Revenue Code of 1986, as hereafter amended, and the applicable rules and regulations thereunder.

No compensation shall be paid to any member, officer, director, trustee, creator or organizer of the Corporation or substantial contributor to it except as a reasonable allowance for services actually rendered to or for the Corporation.

The Corporation is organized to serve public interests. Accordingly, it shall not be operated for the benefit of private interests. Further, the Corporation shall provide equal employment opportunities to all persons, regardless of race, color, national origin, gender, age or religion.

ARTICLE IV - MANNER OF ELECTION

The directors are elected and appointed shall initially be made by the Corporation's sole Director. Subsequent election be provided for in the Corporation's Bylaws. The term, manner of election and removal and number of directors shall be fixed in the Bylaws of the Corporation.

ARTICLE IX - AMENDMENTS TO THE ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended by the Board of Directors, by majority vote, at a meeting of the directors duly called and held in accordance with the Bylaws.

ARTICLE X - DISSOLUTION

Upon the liquidation or dissolution of the Corporation, its assets, if any, remaining after payment (or provision for payment) of all liabilities of the Corporation, shall be distributed to, and only to the District, or if such organization has ceased to exist, to any one or more organizations qualified as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as hereafter amended, and the applicable rules and regulations thereunder which provides educational services to

the residents of Alachua County. Florida. No part of the assets or the net earnings, current or accumulated, of the Corporation shall inure to the benefit of a private individual.

ARTICLE XI - EFFECTIVE DATE

The effective date for filing these Articles of Incorporation with the Secretary of State of the State of Florida is September 6, 2017.
