**Article III Purpose**

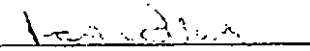

**Article IV Manner of Election**

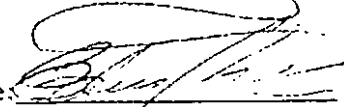

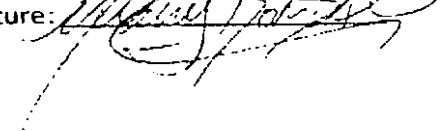

**Article VI Limitations**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No member, trustee, director or officer of the Corporation or any private individual shall be entitled to share in the distribution on any of the corporate assets on dissolution of the Corporation.

The Corporation shall not directly or indirectly carry on any activity which would prevent it from obtaining from Federal income taxation as a corporation described in Code Section 501(c)(6), or cause it to lose such exempt status.

**Article VII Dissolution. Liquidation**

In the event of the liquidation, dissolution, or winding up of the Corporation, whether voluntary or involuntary or by operation of law, all of the remaining assets and property of the Corporation shall, after necessary expenses, thereof, be distributed to one or more organizations which qualifies to preserve the Corporation's exempt status and which will best accomplished the general purposes for which the Corporation was formed.
