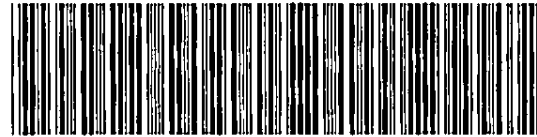

**Articles of Incorporation  
of  
Another Chance Stables, Inc**

The undersigned, acting as incorporator of a non profit charitable corporation under Chapter 617 of the Corporation Act, of the laws of Florida Statutes, adopts the following Articles of Incorporation for the not for profit corporation:

**Article I  
Name and Location**

The name of the corporation is and shall be hereinafter known as:

**Another Chance Stables, Inc.**

The duration of the corporation is perpetual.

**Article II  
Purpose**

The corporation is organized exclusively as a not for profit for charitable, religious, educational, scientific purposes, including, for such purposes, to receive and administer funds for the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax codes and for the purpose of engaging in any activities permitted under the laws of the United States and Florida.

A. To hold, manage, acquire, receive, or take by donations, gifts, contributions, grants, bequest or otherwise any real, personal or mixed property, or any interest therein, of every kind and description, wheresoever the same may be situated from any source, and without limit as to the amount,

including without limiting the generality of the foregoing, money, equipment, land, buildings, shares, bonds, securities including stock, of any donor and any interest in any property which may be necessary or convenient for the conduct of the corporation and to hold, enter into contracts and agreements of every kind, invest, reinvest, use, mortgage, pledge, sell, purchase, lease, assign, give, exchange, transfer or otherwise dispose of the same as may be necessary to further accomplish this corporation's purpose thereof exclusively for charitable, religious, scientific, literary, or education purposes either directly or by contributions that qualify as exempt organizations under 501 (c) (3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

B. The specific purpose of Another Chance Stables, Inc is to provide a program of horse rescue, rehabilitation, relocation, fostering, retraining for another career, retirement, adoption services, rehoming, to provide a sanctuary and safe haven for our equine friends, and to educate the public of responsible horse ownership through proper care, horse welfare, and natural methods of equine training to strengthen the human and equine relationship, and with all animals.

### **Article III**

#### **Stock and Limitations**

A. The corporation shall have no stated capital or capital stock, and shall be composed of members rather than stockholders. It is organized and shall be operated exclusively for religious, charitable, and educational purposes, and not for financial gain. No part of the net earnings of the corporation shall inure to the benefit of, or to be distributed to any member, trustees, officers, or other private persons of the corporation not qualifying as exempt under section 501 (c) (3) of the Internal Revenue Code, as now enacted or hereafter amended, except that the corporation solely shall be authorized and empowered to pay such reasonable compensation for services actually rendered to the corporation, and to make payments and distributions in furtherance of the purposes set forth in these articles of corporation, or allow as a reasonable allowance for authorization expenditures incurred on behalf of the corporation.

B. No part of the activities of the corporation shall be for carrying on of propaganda, or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, nor intervene, including any publishing or distribution of statements, any political campaign on behalf of or in opposition to any candidate for public office, and any receipt of the corporation in excess of the expense of conducting and operating thereof shall be applied by the directors to carry out the purpose of this organization and operations, as they, in their judgement, may deem wise, and shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, as now enacted or hereafter amended.

**Article IV**  
**Election and Appointment of Directors**

Subject to the limitations provided by law, all corporate powers and purposes, business affairs of such corporation shall be managed and conducted by a Board of Directors. The qualifications, manner of elections, term of office, removal of, number of Board Members and Directors, fulfilling vacancies, duties of such positions, shall be prescribed by the By-Laws of the corporation. There are three initial Board of Directors.

**Article V**  
**Debt Obligations and Personal Liability**

No member, officer, director, board member, registered agent of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the personal property of the members, officers, directors, registered agent be subject to the payment of the debts or obligations of this corporation.

**Article VI**  
**Dissolution**

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs, and expenses of the corporation, distribute all assets to such organization(s) organized and operated for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes of such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article VII**  
**Amendments**

The corporation reserves the right to amend, add to, repeal any provision contained in these articles of corporation, in the manner consistent with the laws of the State of Florida, the Internal Revenue Code, and in the conformity with the corporation By Laws. The Board of Directors shall have full power to adopt, alter, and amend the By Laws of this corporation and to make proper rules and regulations for the transaction of its affairs.
