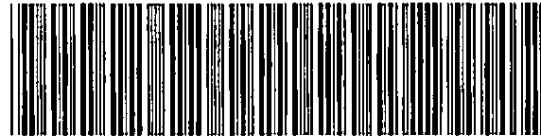

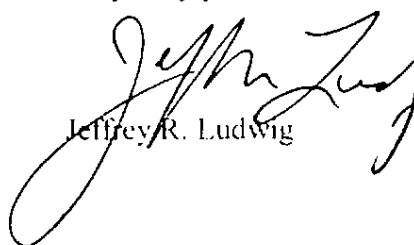

ARTICLES OF INCORPORATION
OF
HELP FOR HOMELESS FOUNDATION, INC.

Jacksonville, Florida
(A corporation not for profit)

ARTICLE I
Name

The name of this corporation is HELP FOR HOMELESS FOUNDATION, INC. Its principal office shall be in the City of Jacksonville, County of Duval, and the State of Florida, at 4964 Greenland Hideaway Dr., N., Jacksonville, FL 32258-1582.

ARTICLE II
Corporate Purpose

The general nature of the objectives and purposes of this Corporation shall be as follows:

- (a) To provide social services to underprivileged individuals including those that are temporarily or chronically homeless.
- (b) To participate in the provision of social welfare programs which may be sponsored by churches, the community, or other organizations including but not limited to providing for the basic needs of homeless individuals, families and children, emergency assistance, social services and prevention guidance for those individuals.
- (c) To undertake new social service activities as circumstances may suggest or demand.

ARTICLE III
Powers

This Corporation shall have all of the powers provided for corporations not for profit by Chapter 617 of the Florida Statutes or corresponding provisions of any subsequent statute and the powers of any other statute or law which do not in any way adversely affect the corporation's status as a corporation not for profit under Chapter 617 or the Florida Statutes.

ARTICLE IV
Members

The members of this corporation may consist of individuals of the local community sharing the desire to help provide the corporate purposes stated above and members of other social service organizations who serve for the betterment of the homeless community at large.

ARTICLE V
Liability

The personal liability of the members for corporate obligations shall be none.

Amendment of Article

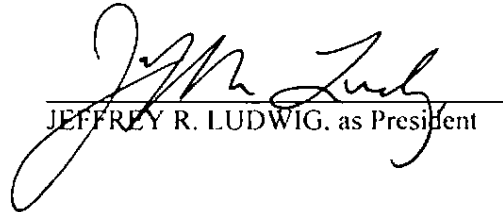

ARTICLE XII

By-laws

The corporation shall adopt such By-laws as may, from time to time be necessary. No By-law is to conflict with these Article of Incorporation. By-laws may be adopted or amended at any legally called and conducted meeting of the members of the corporation by a two-thirds (2/3) majority vote of those present and voting.

ARTICLE XIII

Asset Distribution at Dissolution

All assets remaining shall be distributed to organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE XIV

Prohibited Activities

Notwithstanding any other provision of these Articles, this Corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue Law.
