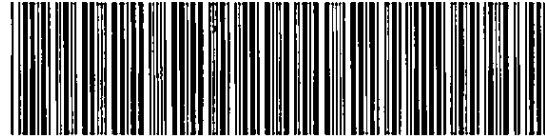



**ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

**OF**

**GREATER CALLING OUTREACH, INC.**

- ONE: The name of the Corporation is **GREATER CALLING OUTREACH, INC.**
- TWO: The duration of the Corporation shall be perpetual.
- THREE: The principal address of the Corporation is:
- 5085 Foxcroft Ct, Orlando, FL 32808**
- FOUR: The general purpose or purposes for which this Corporation is being formed is/are to provide spiritual and life changing support to those in need. Consulting and all other lawful business activity for which the Corporation may be incorporated under Chapter 617 of the Florida statutes.
- A. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State, or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of

the organization is then located, exclusively for such purposes.

FIVE: The manner in which the Directors are qualified, elected or appointed is as follows: Each year at its General Annual Meeting, the members of the Corporations shall appoint the Board of Directors to serve for the ensuing year as provided for in the bylaws.

SIX: The internal affairs of the Corporation shall be governed by the bylaws of the Corporation, which shall be adopted at the first meeting of the Board of Directors.
