ARTICLE I

1.01 Name

The name of this corporation shall be The Interfaith Coalition, Inc. The business of the corporation may be conducted as Interfaith Coalition or Interfaith Café

ARTICLE II

2.01 Duration

The period of duration of the corporation is perpetual

ARTICLE II

3.01 Purpose

The Interfaith Coalition, Inc is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501.c.e of the Internal Revenue Code.

The purpose is to unite people of many faiths and cultural traditions by living shared values of love, peace and justice through interactive family events, shared social action and educational dialogue.

3.02 We provide opportunities for persons of diverse faith and cultural backgrounds to come together in educational and social gatherings including but not limited to such events as The Interfaith Café, Interfaith Family Picnics, and Social Action for Peace and Justice.

ARTICLE IV NON-PROFIT NATURE

4.01 Non-Profit Nature

The Interfaith Coalition, Inc. is organized exclusively for charitable and educational purposes. No part of the net earnings of Interfaith Coalition shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons. The corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose cause hereof.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of The Interfaith Coalition, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of The Interfaith Coalition, Inc. any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501.c.3 of the Internal Revenue Code which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation. The organization(s) to receive the assets of The Interfaith Coalition, Inc. hereunder shall be selected by the discretion of a majority of the managing body of The Interfaith Coalition, Inc.

4.04 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.04 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax as an organization described by Section 501.c.3 of the Internal Revenue Code
