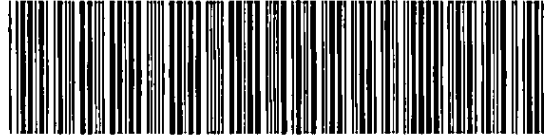

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I **NAME**

The name of the corporation shall be:
IGLESIA CRISTIANA PUEBLO SANTO, INC.

ARTICLE II **PRINCIPAL OFFICE**

ARTICLE III **PURPOSE**

The Corporation is organized and shall be operated exclusively for religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended (or corresponding section of any future federal tax code).

The purposes of this organization are:

- (a) To proclaim the Word of God and to share Christ's life, forgiveness and salvation among us, our community and the world by means of evangelism, mission and church planting.
- (b) To employ and discharge ordained minister of the Gospel, and others, to conduct and carry on divine services at the place of worship of the members of the Corporation, and elsewhere.
- (c) To conduct, accomplish and carry on its objectives, functions and purposes or any part thereof set forth in the Constitution, if any, of IGLESIA CRISTIANA PUEBLO SANTO, INC., as amended from time to time.

The church shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Code or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Code. This church has not been formed for pecuniary profit or gain. No part of the assets, income, or profits of the church shall inure to the benefit of its members, council members, trustees, or officers or to any individual. However, the church shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III.

No substantial part of the activities of this church shall consist of carrying on propaganda, or otherwise attempting to influence legislation. This church shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.


