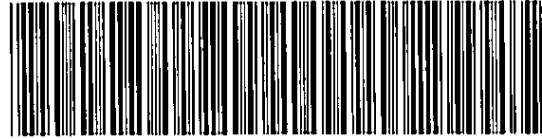

And adopt the following articles of church order and submit ourselves to governed by them.

To be able to build a hospitality center, in which people can stay for a defined amount of time with the purpose of benefiting women, children, youth and men. The children will be educated inside of the school located on Church premises along with the children in the community. There will be an equipment center, as well as a community center in which people will be equipped with the Word of God and will serve both in the church and the community.

To build, construct, erect, maintain mission stations and mission churches, pastor's home and such other houses or equipment as the corporation may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, and requests by or from any persons or corporations.

This corporation is further organized for the purpose of holding the title to such property or properties as the **IGLESIA VIDA EN COMUNIDAD ASAMBLEAS DE DIOS, INC.** shall from time to time purchase or acquire and it shall have power from time to time to make such contracts and do such things as shall be authorized and directed by its members. 
