Add Article IX: Section 1: Dissolution: Should the church become extinct or dissolved, all assets remaining after

discharging the obligations and responsibilities of the corporation shall be turned over to Southeast Region of Open Bible

Churches. In the event the Southeast Region is nonexistent, the assets shall be turned over to Open Bible Churches, an

lowa corporation, or in the event it is nonexistent, to a religious, educational, or charitable organization or organizations

whose objectives are in harmony with those of Open Bible Churches. Such recipient organization or organizations must also

be exempt from federal income taxation under the provisions of Section 501 (c)(3) of the Internal Revenue Code. In no-

event may any of the assets of the church, upon dissolution thereof, be paid to or inure to the benefit of any individual

partner, member of the advisory council, regional board, officer of the corporation, or any other private individual.

Section 2: Withdrawal: Withdrawal from affiliation with Open Bible Churches during the term of regional supervision
