The undersigned incorporator to these articles of incorporation ("Articles") hereby forms a corporation not for profit ("Corporation") under the laws of the State of Florida as follows:

Article I. Name

.

The name of the Corporation is Brooker Creek Watershed Citizens Alliance, Inc.

Article II. Address

The street address of the Corporation's principal office is: 1101 West Swann Avenue Tampa, Florida 33606

Article III. Purpose

The Corporation was organized and shall be operated as a tax-exempt organization exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or any of its successor laws ("**Code**") and relevant provisions of the Act. More specifically, the Corporation's purpose includes:

- (A) Protecting the Brooker Creek watershed's ecosystem, including habitat, wildlife, groundwater, and surface water, for the public benefit in Hillsborough and Pinellas County, Florida;
- (B) Preserving and protecting Brooker Creek and its watershed from air and water pollution and other environmental hazards in order to secure the multiple public benefits that follow from a clean, unimpacted creek and watershed, including safe drinking water, flood control, abundant and diverse wildlife populations, healthy recreational activities, and economic benefits from commercial activities that depend upon the environment of Brooker Creek and its watershed;
- (C) Preserving and protecting the natural beauty, recreational value and rural character of Brooker Creek watershed area;
- (D) Ensuring that the Brooker Creek watershed area will continue to be available for future generations to enjoy the rural lifestyle and recreational qualities of the watershed including, wildlife observation, hiking, horseback riding, educational study, aesthetic enjoyment and spiritual contemplation;
- (E) Promoting the health and well-being and improving the quality of life of those who live and recreate within the Brooker Creek watershed area; and

(F) Advocacy for Brooker Creek and its watershed, including:

- (1) raising public awareness of the public benefits of Brooker Creek and its watershed,
- (2) seeking federal and state agency implementation of state and federal water quality and environmental laws to protect Brooker Creek and its watershed.
- (3) enforcing environmental and land use laws designed to protect the health, safety, and welfare of those who live, work, and recreate in the Brooker Creek watershed,
- (4) protecting the public from the health impacts of pollution and other environmental hazards and improving environmental quality for the public benefit.
- (5) protecting and preserving the environment not only within the Brooker Creek watershed but also those water bodies that are connected to Brooker Creek including Tampa Bay and other water bodies, streams and tributaries, and
- (6) as necessary, initiating legal action on behalf of the Corporation to protect the Brooker Creek watershed and its rural character.

Article IV. Directors

Article VI. Registered Office and Registered Agent
