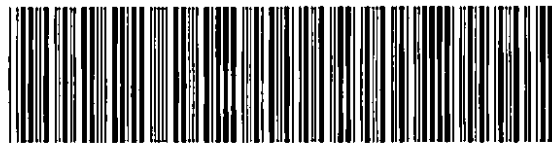

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of a corporation under the provisions of Chapter 617 of the laws of the State of Florida adopt the following Articles of Incorporation:

**ARTICLE I**

NAME: The name of this corporation is:

**MOVIMIENTO PALABRA DE VIDA ETERNA, INC.**

**ARTICLE II**

**NATURE OF BUSINESS:**

The business of this corporation shall be the propagation and dissemination of the gospel of Jesus Christ through the preaching, teaching, and living of the Full Gospel Message as outlined in The Doctrine and Discipline of the Movimiento Palabra De Vida Eterna, Inc., constitution and Bylaws of Movimiento Palabra De Vida Eterna Inc., having its principal place of business in Lake Worth, FL, and shall be based on the Bible as the inspired word of the living God. This corporation shall have the power to purchase, lease and construct churches, schools and other building structures useful in connection with the carrying out of the purposes and objects of the corporation.

### ARTICLE VIX

BYLAWS: Bylaws of this corporation shall consist of the bylaws of The Doctrine and Discipline of Movimiento Palabra De Vida Eterna, Inc. having its principal place of

business in Lake Worth, FL. and such additional bylaws as may be passed by a majority vote of the members present at any business meeting of this corporation not inconsistent herewith.

MEMBERSHIP: Membership of Movimiento Palabra De Vida Eterna, Inc. shall consist of those individuals who are 12 years of age or over and who have been officially and publicly received into membership of the church and who are in accord with the express purpose of Movimiento Palabra De Vida Eterna, Inc. as set forth by The Doctrine and Discipline of the Movimiento Palabra De Vida Eterna, Inc. Any child under the age of 12 years shall be considered an integral part of the church in filial relationship. Voting privileges shall be accorded to all members for a period of at least 30 days and who shall have met the qualifications of the active members as set out below.

ACTIVE MEMBERS: Each member must subscribe to and adhere to the doctrine of the full gospel as outlined in the Articles of Faith compiled by the General Board of Directors. Members should be received into Movimiento Palabra De Vida Eterna, Inc. once each month, or as often as may be deemed necessary; they shall be examined prior to admission by the pastor and examining committee and shall have shown evidence of genuine born-again experience and a godly Christian life. Members shall be expected to give physical, financial, and spiritual cooperation according to their abilities.

The principal pastor of a church and his wife shall be members of his church by virtue of the pastoral call and shall exercise full membership privileges.

Officers – The officers of Movimiento Palabra de Vida Eterna, Inc. shall be as follows: pastor, board of elders of not less than three or more than seven members

(including the pastor), two or more deacons (any of whom may be members of the board of elders), and such other offices as may be determined by the policy of the church.

A pastor shall be initially elected to his church for a term of five years and may be re-elected for a term of one to five years, according to the policy of the local church. It is understood that any pastor whose term expires shall be eligible to succeed himself. The officers of the church, except the pastor, shall be nominated by the pastor and the present board of elders, and shall be elected by majority of the members of the affiliated church present at a membership business meeting duly called for that purpose. All church officers (except pastor) shall be elected or appointed for a term of from one to three years as may be determined by the policy adopted as bylaws by Movimiento Palabra de Vida Eterna, Inc.

#### **ARTICLE X**

**AMENDMENTS:** Amendments of these Articles of Incorporation may be made at any regular meeting of the membership of the church by a two-thirds vote of the members present and entitled to vote.

#### **ARTICLE XI**

**PERSONAL LIABILITIES:** No member of this corporation shall be liable for debts of the corporation. Private property of the members of this corporation shall be exempt from corporate debts and liability.

## ARTICLE XII

DISSOLUTION: In the event the church shall cease to support a minister or leader or have regular services for six months, it shall be deemed extinct, and all assets remaining after discharging all obligations and responsibilities of the corporation shall be turned over to a religious, educational, or charitable organization or organizations whose objectives are in harmony with those of Movimiento Palabra de Vida Eterna, Inc. Such recipient organization or organizations must also be exempt from Federal Income Taxation under the provision of Section 501 (c) (3), or as such section may be amended.

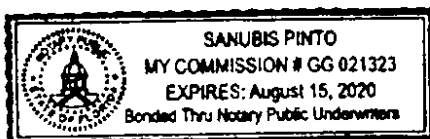

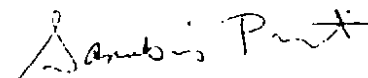

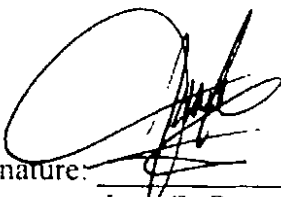
