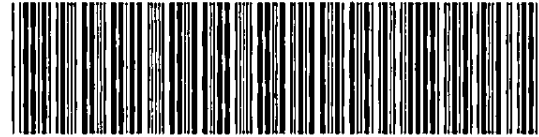

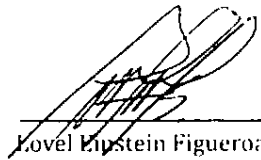
Please amend Article 3 to read as follows:
