John Ward for Congress, Inc.**

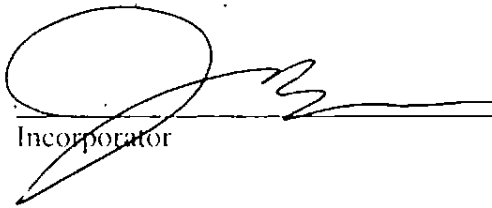
- Article I:** The name of the Corporation is John Ward for Congress, Inc.
