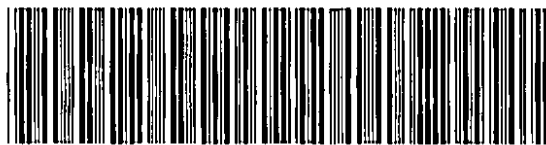



(Not for Profit)**

ARTICLE I: NAME
