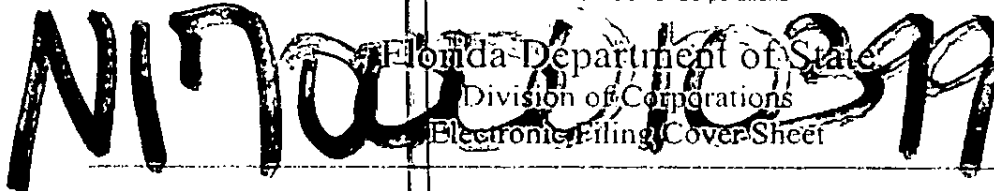

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
SUGAR VOLUNTEERS, INC.

Pursuant to Section 617.0006, Florida Statutes, SUGAR VOLUNTEERS INC., desires to amend its Articles of Incorporation having been filed with the Florida Secretary of State under Document Number N17000010399 (collectively the "Articles of Incorporation").

1. **Article III.** is hereby deleted in its entirety and a new **Article III.** shall replace any existing **Article III.** provisions of the previously filed Articles of Incorporation. **Article III.** shall read as follows:

ARTICLE III. PURPOSE

The purposes for which the Corporation is organized are for educational and charitable purposes in relation to connecting children with volunteering opportunities that fall within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, and in this connection:

(1) To provide services and hold community events that benefit the public in a manner that complies with the requirements for tax exemption under Section 501(c)(3).


(2) To provide funds to other entities exempt from income tax under Section 501(c)(3).

(3) Generally, to have an exercise all rights and powers conferred onto nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including, but not limited to, the power to contract, rent, buy or sell personal or real property.

2. All other terms and provisions of the Articles of Incorporation that were originally filed with the Secretary of State under Document Number N17000010399 shall remain unchanged.

3. The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
