
**ARTICLES OF DISSOLUTION

1. The name of the corporation not-for-profit is YAYA'S HOUSE, INC. (the "Corporation").
2. The Articles of Incorporation of the Corporation were filed on October 19, 2017 and assigned document number N17000010531.
3. The Corporation has no members.
4. The dissolution was unanimously approved by the Board of Directors of the Corporation on December 21, 2018.
5. The effective date of the dissolution of the Corporation shall be the date these Articles of Dissolution are filed with the Department of State of the State of Florida.
6. All debts, obligations and liabilities of the Corporation have been paid or discharged.
7. All remaining property and assets have been distributed in accordance with the plan of distribution of assets adopted unanimously by the Board of Directors of the Corporation on December 21, 2018 in compliance with Section 617.1406(2), *Florida Statutes*, and in accordance with Section 501(c)(3) of the Internal Revenue Code.
8. There are no suits pending against the Corporation in any court.



YAYA'S HOUSE, INC.


