The undersigned, desiring to form a not for profit corporation under and by virtue of the provisions of Chapter 617 of the Florida Statutes, hereby make, subscribe, and file these Articles for that purpose, as follows:

ARTICLE I

Name

The name of this corporation shall be Dock Acquisition Corp.

ARTICLE II

**Initial Registered Office and Agent,

The initial registered office of this corporation shall be located at 505 South Flagler Drive, Suite 1100, West Palm Beach, FL 33401, and the name of the initial Registered Agent of this corporation at said address shall be JONES FOSTER SERVICE, LLC. ARTICLE III

Purposes and Powers

Sovereignty Submerged Land Lease No. 500035086 with the Trustees of the Internal Improvement Trust Fund of the State of Florida as lessor (the "Submerged Land Lease"), (ii) own, repair, maintain, operate and administer the docks and related improvements constructed on the submerged land leased to this corporation pursuant to the Submerged Land Lease, (iii) to exercise any rights available to this corporation by virtue of the Submerged Land Lease and the docks and improvements constructed on the submerged land, and (iv) take such actions and perform such services as may be necessary and proper in connection with the foregoing purposes.
