**Article I. Name**

The name of the corporation shall be: Joshua Academy Inc.

**Article II. Principal Office**

The initial principal place of business and mailing address of the Corporation shall be:

**Article III. Purpose**

The specific purpose for which the corporation is organized is as follows:

This Corporation shall operate a private, non-denominational Christian school. The Corporation shall admit students of any race, color, national and ethnic origin to all the rights, privileges, programs and activities generally accorded or made available to students at the school. Further, the Corporation shall not discriminate on the basis of race, color, national and ethnic origin in the administration of its educational and admission policies nor in its scholarship, athletic and other school administered programs.

This Corporation is organized exclusively for charitable, religious and educational purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

This Corporation will not attempt to influence legislation as a substantial part of its activities and will not participate at all in campaign for or against political candidates.

In addition, none of the earnings of the corporation will inure to any private shareholder or individual, except for reasonable compensation for services rendered.

If the Corporation dissolves, its assets must be distributed for an exempt purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code.

#### **Article IV. Management**

The Corporation's affairs shall be managed in accordance with the Corporation's bylaws. The number of directors may be increased or decreased in accordance with the Corporation's bylaws, but shall never be less than the minimum required by law.

#### **Article V. Manner of Election**

The manner in which the directors are elected or appointed is as provided for in the bylaws.


