The undersigned President of ORANJESTAD ARUBA SISTER CITIES ASSOCIATION CORP. executes these Restatement of Articles of Incorporation of ORANJESTAD ARUBA SISTER CITIES ASSOCIATION CORP. pursuant to Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is ORANJESTAD ARUBA SISTER CITIES ASSOCIATION CORP, (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 3 - PROHIBITIONS

No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for

public office. Notwithstanding any other provision of these Restatement of Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 4 - ADOPTION

These Restatement of Articles of Incorporation were adopted on 5 March 2020, and the number of votes cast by the Members for the Amendment of the Restated Articles of Incorporation was sufficient for approval.

ARTICLE 5 - PRINCIPAL OFFICE

ARTICLE 6 - OFFICERS

ARTICLE 8 - INCORPORATOR

This Corporation shall have perpetual existence.

ARTICLE 10 - CAPITAL STOCK

Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
