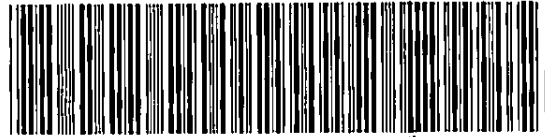


In accordance with the information and requirements as outlined within your instructions for filing of a "Not For Profit Articles of Incorporations", we are submitting herewith the following:

ARTICLES OF INCORPORATION OF PRIMERA IGLESIA BAUTISTA HISPANA DE KISSIMMEE, INC.

ARTICLE I:

The name of this corporation shall be: *Primera Iglesia Bautista Hispana de Kissimmee, Inc.*

ARTICLE II:

The principal place of business of the corporation is: *2820 Michigan Avenue, Kissimmee, Florida, 34746*
The mailing address of the corporation is *P. O. Box 450266, Kissimmee, Florida, 34745.*

ARTICLE III:

The purpose of the corporation will be to promote the Kingdom of God. This will be done in corporate worship, by public testimony, by the proclamation of the gospel with **love, integrity, passion, justice and compassion.** by projects of mission service, through a Christian Education program that affirms all creation and children of God, by promoting our Christian faith, by defending justice for all, in serving and helping the poor as ourselves with physical and spiritual needs.

ARTICLE IV:

The directors of the corporation shall be elected by written ballot or by majority vote of this corporation and shall serve for three (2) year terms or until their successors are elected. Their terms shall begin at the close of the annual meeting at which they are elected. Any voting member of this corporation may be elected, subject only to the limitation on the length of continuous service permitted in that office.
