Articles of Incorporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be Asociacion de Iglesias Cristiana Casa de Oracion Puerta del Cielo, Inc.

Article 2 Principal Office
