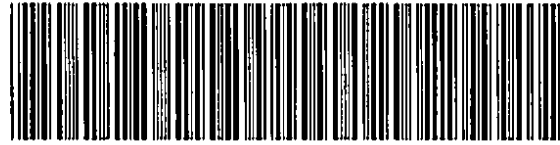

**ARTICLES OF INCORPORATION FOR  
US ADRIFT, INC.  
A FLORIDA NOT-FOR-PROFIT CORPORATION**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation adopts the following articles of incorporation:

**ARTICLE I**

The name of the not-for-profit corporation shall be: US ADRIFT, INC.

**ARTICLE II**

The principal place of business, and mailing address, shall be 740 4th Street N, #123, St. Petersburg, Florida, 33701.

**ARTICLE III**

The specific purpose for which this not-for-profit corporation is organized is exclusively for charitable, religious, educational, or scientific purposes under §501(c)(3) of the United States Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IV**

In the event of dissolution of this not-for-profit corporation, all assets shall be distributed for one or more exempt purposes within the meaning of §501(c)(3) of the United States Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


**ARTICLE V**


