

ARTICLES OF INCORPORATION

of the

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE 1 - NAME

The name of the Corporation shall be the "Phi Delta Phi Legal Institute, Inc.".

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - STATEMENT OF PURPOSE

The purpose or purposes for which the Corporation is organized and for which it shall exist are to operate solely and exclusively as a charitable, literary and educational institute, not for profit, with the power to administer, hold, invest and reinvest such funds as may be received by it from gifts, wills, bequests, grants, contributions, or otherwise, which together with the earnings shall be used exclusively for charitable, literary and educational purposes, including the award of scholarships, and the administration thereof; including but not limited to facilitating the cultivation and diffusion of knowledge and understanding of the law through the undertaking of original research, publication of findings, sponsorship of conferences, debates, and media of all types with the objective of advancing the legal profession through analysis and recommendations for improving the legal profession.

VI - PROHIBITED ACTIVITIES

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose herein. The property of the Corporation is dedicated to the purposes set forth herein, and no part of the net income of assets of this Corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

VII. DISTRIBUTIONS UPON DISSOLUTION

The Corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the Corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damages and/or degrade the corporation, or as otherwise provided under applicable statute.
