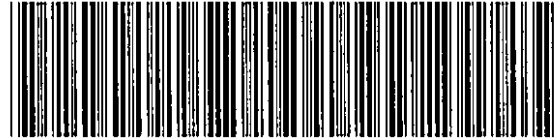



ARTICLE NINE


The manner in which the Corporation elects its Directors is in accordance to the By Laws.
