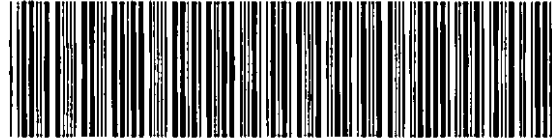

Pursuant to Chapter 617.0202, F.S. We make and adopt the following articles of incorporation.

Article I. The name of the corporation is:  
**We The People of Deerfield Beach, Inc.**

Article II. The principal address of the corporation is:  
559 NW 47 Terrace, Deerfield Beach, Florida 33442

Article III. Purposes: To create a group of members of one hundred or more, being qualified as registered voter/citizens of Deerfield Beach Florida. This group will promote citizen awareness and involvement with the goal of contributing to improving our local city government and its essential service to all of the citizens and businesses of the city. To work with the local government when common interests abound. To endeavor to place restraints on the local government from time to time. To take any action considered essential while maintaining propriety. To obey all laws within the Florida Statutes and the City of Deerfield Beach Municipal Code and Ordinances. Actions considered essential may be, but are not limited to those found within City of Deerfield Beach Municipal Code and Ordinances, Article VII., Recall, Initiative and Referendum .

Article IV. The Directors/Officers are appointed.

Article VIII. The initial Directors are appointed the incorporator, and thereafter there is no limitation on the number of directors except to the extent as determined by the Board of Directors. The initial Board of Directors shall appoint within themselves the initial Officers. The Board of Directors may expel a member if it serves the best interests of the organization. A majority of the Board of Directors is required to expel a member.

Article IX.. The corporation is a not for profit as allowed by Florida Statutes Chapter 617.0202 No part of any income will be distributable to any officers , directors or members except as permitted by these articles and as allowed under Florida Statutes and Federal Law. The corporation shall be authorized and empowered to pay for services rendered and reimbursement in furtherance of the purpose of the corporation.

Article X. The powers of the corporation will controlled and directed by its Officers which include all activities, affairs and property.  
The Board of Directors shall initially be three or more persons and shall include officers: President, Vice-President, Secretary and Treasurer. A person may hold more than one office except the President may not be a Vice-President or Secretary. The Board of Directors may be increased from time to time as may be needed. There may be more than one Vice-President. All voting decisions shall be determined by majority. There must be a majority of the total Board of Directors to delete, modify or add any Articles. This may done from time to time if the Board feels it necessary to better improve the corporation. The Board shall determine its officers by appointment and may alter or remove officers by vote.  
**The corporation is non-partisan and political view points are not expressed.**


Article XI. BYLAWS. The Board of Directors if it chooses, may decide to add Bylaws for rules of procedures and conducting necessary activities. The Bylaws may be increased, amended or deleted at the decision of a majority of the Board of Directors.

Article XII. The membership of the corporation is open to any qualified person or business approved by the Board of Directors.

- Article XIII. The duration of the corporation will be perpetual unless dissolved in accordance with law. The corporate existence will commence with filing these Articles.
- Article XIV. Non-members may provide submissions for actionable consideration to the Board of Directors.
- Article XV. Indemnification and Civil Liability Immunity. It is intended that this corporation Directors and Officers be immune from civil liability to the extent provided under the laws of the State of Florida, Statutes Chapter 617 and any other statutes which may apply.


