THE SPECIFIC PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS:

Asociacion Mocamia, Inc is organized exclusively for charitable, cultural and educational purposes. It also serves as an entity that coordinates aid between institutions and people who need resources in health, housing and economic support, by collecting funds from the community and it's members. It integrates for the latin community residing in Florida and

contributes with the common good. Including for such purposes, the making of distributions to needy organizations that qualify as exempt organizations described under section 501 (c) (3) of the internal code, or corresponding section of any future tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the International Revenue Code, or corresponding section of any federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organizations is then located, exclusively for such purposes or to such organization, as said court shall determine, which are organized and operated exclusively for such purposes.
