Upon the Dissolution, the Assets shall be distributed for one or more exempt 501 (c) (3) of the Internal Revenue Code Organizations listed below as long as they maintain their exempt status.

No part of any of the Revenue of the Foundation will benefit the Foundation creator or anyone else in her family. There will be no payments to any Shareholders, Members or Directors of the Foundation Entity.

No part of the Foundation Funds will be used for any Political Candidate or Legislature purpose. No Political Activity to Lobbying will be paid from the Foundation.


