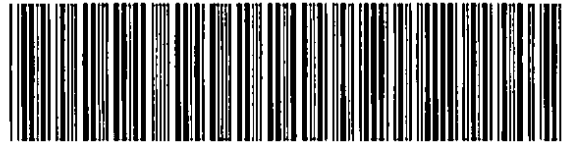

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of incorporation.

I. Name

II. Purpose

2. To initiate the formulation and implementation of programs designed to alleviate the negative outcomes associated with the mal- and discriminatory treatment of women in worldwide.

4. To operate exclusively for charitable, religious and educational purposes within the meaning of section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1986 any corresponding provisions of any future Internal Revenue Law.

The initial Board of Directors will be appointed by the incorporator (s) once the entity is incorporated as a domestic corporation of the State of Florida.

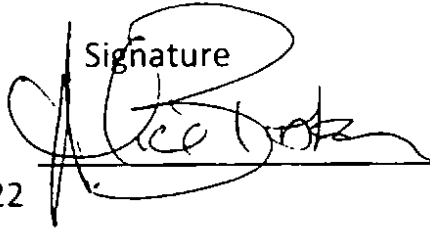

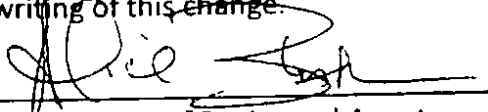
