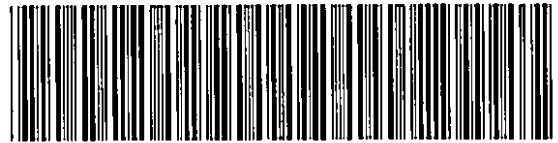



Articles of Incorporation

Articles of Incorporation of REACH BACC, INC

The undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of the state of Florida, do hereby certify:

Article I: Name

The name of the corporation shall be REACH BACC, INC

Article II: Address

The place in this state where the principle office of the Corporation is to be located in Miami-Dade County

Article III: Purpose

This corporation is organized exclusively for educational purposes, to provide education and training to youth and their families not limited to parenting, mentoring, teaching and extracurricular activities. The making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: Directors

The board of directors will be elected by the process stipulated in the bylaws of the Corporation.

Article VII: Limitations

No part or the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or others, or other private persons, except that the Corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth Article Third hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII: Dissolution

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
