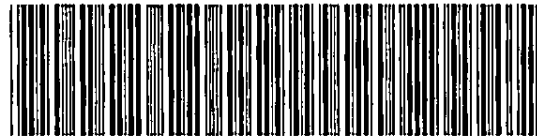

ARTICLE I NAME

The name of the corporation shall be The Giudice Family Foundation, Incorporated.

ARTICLE II PRINCIPAL OFFICE


