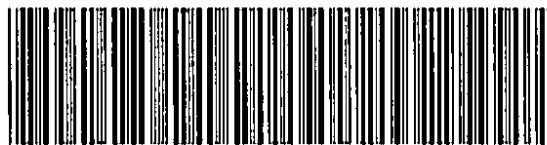

Articles of Incorporation of Beyond the Reef Foundation, Inc.

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I.

The name of the Corporation is Beyond the Reef Foundation, Inc.

Article II.

The principal place of business is 816 Weeden Island Drive, Niceville, Florida, 32578. The mailing address of business is P.O. Box 219, Niceville, Florida 32588.

Article III.

The specific purpose of this Corporation shall be solely to

- A. Propagate the gospel of Jesus Christ through the establishment and maintenance of a ministry of the Christian faith.
- B. To propagate the gospel and further the cause of the kingdom of God in the State of Florida, the United States of America and in foreign lands by the creation and maintenance of Christian churches and ministries.
- C. To provide foundational Bible lessons and work together with national and western Christian translators to see these lessons translated clearly and meaningfully into different languages. In the process of translating, we also will offer training and consultant

oversight to ensure that these lessons engage culture and together with the scriptures communicate at a worldview level for the purpose of building Christ's church to maturity. If no scriptures exist yet in the target language, or scriptures are present, but don't communicate to the target people, we endeavor to help to see a clear and meaningful translation completed. If there is no existing literacy program in the target language, we offer consultant help and training to develop a sustainable working literacy program.

- D. To promote fellowship and means of cooperation between churches of like faith and doctrine.
- E. To promote freedom of worship and liberty of expression within the limits of its own statement of faith and doctrine, among its own churches, ministers and members.
- F. To act with charitable and benevolent concern toward the indigent and impoverished through the distribution of food, clothing, and medical and financial aid as well as to provide short-term relief shelter and long-term housing to truly need and deserving individuals and families, as funds and resources are available.
- G. To conduct training of missionaries and ministers, to license and ordain qualified individuals to preach the gospel, including graduates of the ministerial training program of the Corporation, and provide credentials for same; to receive, gold and disburse gifts, bequests, devises, and other funds for said purposes, and to do all things necessary and incidental thereto, all in accordance with the rules, regulations and doctrines of the Corporation.

- H. To establish and maintain Bible and training schools, inaugurate and maintain charitable institutions, such as orphanages and homes for the indigent.
- I. To maintain such relations with local, state, federal and foreign governments as may be necessary for the successful accomplishment of the purposes of the organization and for the welfare of the mission, ministers and missionaries thereof.
- J. To receive contributions, to make donations, and to dispense charitable contributions through, and otherwise aid and support, those organizations qualified for exemption from the Federal Income Tax under Section 501 (c) 3 of the Internal Revenue Code of 1986, as now in effect or subsequently amended.
- K. To fulfill the Great Commission of Christ by supporting missions, both foreign and domestic, and supporting those performing the work of carrying the gospel as missionaries, both Corporations and individuals.
- L. To minister the Word of God and spread the Gospel by conducting religious services and evangelistic crusades in established churches and in public meeting facilities, through various forms of ministries and through all lawful means, under the direction of the Lord Jesus Christ in accordance with all the provisions set forth in the Holy Bible. To engage in the functions of media broadcasting, including, but not limited to, television, AM/FM transmissions, satellite transmission, internet, and other means of electronic transmissions of music and messages.

Article IV.

The manner in which directors are appointed or elected will be an initial board appointed by the President; any vacancy occurring in the Board of Directors, from whatever cause arising, shall be filled by nomination by the President and a majority vote of the remaining members of the Board of Directors at the next regular meeting or special meeting thereof. Additional members can be appointed as the foundation grows.

Article X.


