ARTICLE III PURPOSE

Said incorporated is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. In detail, the activities shall include the following:

- 1. Prison Visitation Program
- 2. Dharma and Mediation Teaching for public
- 3. Educate the kids in school and college about Buddhism and Meditation.
- 4. Poverty alleviation, and Feeding homeless program.
- Orphanage residence and education.
- 6. Support the Buddhist monks and nuns practitioner in the temples and monasteries.

No part of the net earnings of the incorporated shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the incorporated shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth as foresaid. No substantial part of the activities of the incorporated shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the incorporated shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the incorporated shall not carry on any other activities not permitted to be carried on (a) by an incorporated exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an incorporated, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the incorporated, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the incorporated is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION

The directors will be appointed based upon a vote conducted by the current approved directors of the company. In the event of a tie if there is an even number of existing directors, the President with have the deciding vote.
